**Petition to the Civil Grand Jury of Ventura and Los Angeles Counties and to the Little Hoover Commission**

**Whereas** an independent voice responsive to the people is needed to inform the voters as shareholders in a democracy, *and*

**Whereas** Retired Sheriff Deputy Michael Chilton has gone on record (<https://youtu.be/SIzvE23RU2s>) stating there is a **COVER-UP**, *and*

**Whereas** the controlled propaganda media **lies, disinforms, and covers-up the truth** concerning the events of November 7 – 9 in Thousand Oaks, CA at the **Borderline Bar and Grill**, *and*

**Whereas** falsehoods, inconsistencies, strange coincidences, cases of nepotism, poor evidential custody, public official foreknowledge, lack of transparency, failure to comply with the California Sunshine Amendment/Public Records Act, psychological warfare techniques, and grift characterize the public agency response to the Borderline Bar and Grill *and*

**Whereas** Ronald Reagan authorized domestic covert actions in 1982, *and*

**Whereas** there is no reasonable prospect for criminal enforcement, *and*

**Whereas** staged and fictitious/simplified narratives **can lead to copycat crimes** such as Sutherland Springs, *and*

**Whereas** the Constitution of California and the California Government Code establish the Civil Grand Jury and Little Hoover Commissions as anticorruption and antiracketeering bodies invested with **subpoena power** to examine government records, interview witnesses, publish documents, and report their findings to the public, *and*

**Whereas** the California Association of Sheriffs Deputies has stated the Civil Grand Jury is an **oversight body**,  
**I PETITION YOU** to investigate the facts and circumstances surrounding Local Agency response to the Borderline Bar and Grill Incident, identify the off and on duty law enforcement officers to the public, interview them, review surveillance footage of their response inside the facility, identify any and all military connections of those associated with the incident, and **publish all information to the public**.

**Whereas** falsehoods, inconsistencies, strange coincidences, nepotism instances, poor evidential custody, public official foreknowledge, psychological warfare techniques, lack of transparency, failure to comply with the California Sunshine Amendment/Public Records Act (such as releasing autopsy records), and grift characterize the public agency response to the Borderline Bar and Grill incident of November 7-9, *and*

**Whereas** The California Constitution and California Government Code invest Cities and County governing boards with legislative **subpoena power** so that they may hold hearings and make findings for the purposes of proposing local ordinances and public retirement boards so they may investigate allegations of **fraud**,

**I PETITION YOU** to schedule legislative hearings and issue subpoenas *deuces tecum* for all off/on duty local law enforcement witnesses and for agency records including autopsy and surveillance/bodycam video footage and 911 recordings (which should be public records anyway under the law), take testimony at such hearings including testimony from medical personnel and crisis actors, play all surveillance video footage and similar records in public, and enter all autopsy records into the legislative minutes so that the public may see for themselves the true nature of gun violence and thus debate issues of public policy on emergency response, active shooter drills in preschools, and their psychological impacts based on *facts* rather than manipulative and simplified “news” based upon *spin* and *emotion*.
